## INTRODUCTION

We are a company established in the Netherlands, Chamber of commerce number 01155600, with a registered office at Emmastraat 15 C208, 9712 EW, Groningen, and for the purpose of the General Data Protection Regulation (the "GDPR"), we are a Film & Animation production company.

We collect this information in order to:

- measure and understand the effectiveness of the content we serve to you and others.

## DO WE USE COOKIES?

We use cookies to allow us to recognise and count the number of users and to see how users move around the Website when they are using it. This helps us to improve the services we provide to you and the way the Website works. You have the right to decide whether to accept or reject cookies. You can set or amend your web browser controls to accept or refuse cookies. If you choose to reject cookies, you may still use our Website.
